### 1. Bidding Procedure

1.1 To be qualified for the work, NGOs (bidder) should meet the following requirements:

- (a) A registered NGO (non-profit) (bidder) working in the field of Animal Welfare/related activities, duly recognised by the Animal Welfare Board of India (AWBI) and having eligibility to obtain Project Recognition in accordance with *ABC Rules, 2023* are eligible to submit the Bids.
- (b) The bidder should be well aware/conversant with the methodologies of carrying out ABC-ARV surgery and census/survey and of street dogs, as per the Module published by AWBI.
- (c) The bidder should have carried out 10,000 ABC-ARV surgeries of stray dogs successfully in the last 4 years.

Along with the documentary proof in support of above requirements, bidder shall provide the following documents:

- (i) Copy of Registration with AWBI which should be valid at the time of bid submission.
- (ii) Copy of the Registration Certificate/Trust Deed (Registration under FCRA or Society Registration Certificate or Trust Act) of the applicant organization.
- (iii) Written Consent that in this ABC-ARV Program same Catching Technique, Transportation Protocols, De-wormers, Vaccines, Drugs, Suture Material, Anesthetic Protocol, Surgical Protocol, handling & Maintenance of dogs shall be followed as per the "*Revised Module for Street Dog Population Management, Rabies Eradication and Reducing Man Dog Conflict*" submitted by AWBI in the Supreme Court (This consent has been mentioned in Technical Bid Form-II)
- (iv) Written consent that bidder will deploy a minimum 2 Qualified Veterinary Doctors having collective experience minimum of 1000 (at least 500 per veterinarian) ABC-ARV Surgeries of stray dogs, 4 Paravets & 4 dog Catchers (This consent has been mentioned in Technical Bid Form-II).
- (v) Attested Registration Certificates for each Veterinary Doctor from Veterinary Council of India/State Veterinary Council
- (vi) Copy of Annual Statement of Accounts issued by Chartered Accountant showing minimum cash flow of Rs 15 Lakh for the previous financial year.





(vii) Bidder shall submit written consent for bid validity of 4 months (This consent has been mentioned in Technical Bid Form-II).

(viii) Each page of Technical Bid Form-I to Technical Bid Form-V & Financial Bid Form must be signed by authorized signatory of the applicant organization.

(ix) The bid proposal should be submitted on the bid document (Technical Bid Form-I to Technical Bid Form-V & Financial Bid) downloaded from the official website of [www.saharanpurnagarnigam.com](http://www.saharanpurnagarnigam.com) having official seal.

1.2 Single Stage Two Envelope bidding procedure shall be followed Bidding is open to all eligible bidders

1.3 Envelope -1 shall contain all the requisite documents pertaining to the qualification criteria Envelope -2 shall contain price proposal. Both the envelopes shall be kept in a single outer envelope Name of the bidder should be marked on each of the envelope Bidder has to submit documentary proof in support of qualification requirements and other requisite documents in Envelope-I. In absence of documentary proof, the employer may reject the bid. The employer has the right to confirm the genuineness of the documents submitted.

1.4 Envelope -2 shall be opened for only those bidders who qualify in the first round (Envelope-I). In the second round (Envelope-2) Least Cost selection method shall be adopted for award of work.

1.5 The interested bidder may obtain the Bidding Document for free of cost from the office of **Saharanpur Municipal Corporation.**

1.6 Interested eligible Bidders may obtain further information from the above mentioned office from 10AM to 5PM hours on any working day.

1.7 Bidding document is also available and can be downloaded from our website ([www.saharanpurnagarnigam.com](http://www.saharanpurnagarnigam.com)) Eligible interested bidders can see and download the document and can participate in bidding procedure.

1.8 Bidders are requested to visit the website regularly for clarifications / further information or Addendum to the Bidding Document.

1.9 Bids must be delivered in hard copy to the address mentioned below on or before 3pm on 13.08.2025 Bids received later than the above specified date and time shall be rejected. **No bid shall be accepted by any other means like fax, email etc.**

1.10 The Employer will not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.

1.11 Pre-bid meeting with the bidders shall be held at the office of the Municipal Commissioner office Saharanpur at 11AM on 30.07.2025 Bidders interested in participating in the bid process are advised to attend a pre-bid meeting before submission of bid .

1.12 The hazards/untoward incidents of any kind which the eligible bidders come across while carrying out the survey of the stray/street dogs (after this work is awarded to the eligible bidder) would be at the risk and cost of that bidder.

1.13 The Employer reserves the right to cancel any or all bids at any stage of the process without assigning any reasons thereof to the concerned bidder(s).

1.14 Any queries may be addressed to the office of **Municipal Corporation Saharanpur.**

1.15 Both Technical/Financial Bid will be open at 11AM on 14.08.2023 at the office of **Municipal Commissioner Saharanpur.**

1.16 The Performance Guarantee shall be submitted as follows; 10% of the total amount, i.e. Rs20,000/-, shall be submitted at the tender submission as Earnest Money Deposit (EMD) in the form of FDR, in favour of the Municipal Commissioner Saharanpur. The Remaining 90%, i.e., Rs180,000/-, shall be submitted in the form of FDR in favour of the Municipal Commissioner Saharanpur, after the award of the tender.

## 2. Background

2.1 Mass scale ABC-ARV Program is to be implemented in the area of Saharanpur Municipal Corporation Prime target should be more than 75% of the total stray dog population to be Surgically Sterilized & Vaccinated within a period of 6 years. In this Mass Scale ABC-ARV Program, only those Material, Anesthetic Protocol, Surgical Protocol, handling & Maintenance of dogs shall be followed which confirms the "Revised Module for Street Dog Population Management, Rabies Eradication and Reducing Man Dog Conflict" published by AWBI.

2.2 On the basis of WHO Guidelines Stray Dog Population is expected to be nearly 3% of the human population. These stray dogs are to be covered under this program. The actual data may vary as per actual survey conducted.

2.3 The ABC Campuses shall be provided to bidder including Operation Theatre + Kennels + Well Constructed Rooms + other basic infrastructure like Operation Tables, Drip Stands, Autoclave, Basic Furniture, Refrigerator, Washing machine, Inverter, + Dog Vans + CCTV surveillance system +Animal Helpline Number.

## 3. Scope of Work

3.1 The bidder shall deploy a minimum 2 number of Qualified Veterinary Doctors; with the collective experience of at least 1000 (at least 500 per veterinarian) ABC-ARV Surgeries, 4 Paravets, 4 dog Catchers & drivers for dog vans.

3.2 Dog vans will be provided by the **Saharanpur Municipal Corporation, Uttar Pradesh. Local body.** These dog vans will be operated by the bidder. All expenses pertaining to operation & maintenance including POL, tyres & tubes etc. and drivers, of these dog vans will be borne by the bidder Cost towards satisfactory repair of the damages to the vehicles during operation, if any shall have to be borne by the bidder, falling which, such cost shall be liable for deduction from eligible payments of the bidder. **The dog vans shall have to be returned back to the respective Saharanpur Municipal Corporation, Uttar Pradesh. after completion of the contract.**

3.3 It shall be the responsibility of the bidder to carry out (a) catching the street/stray dog (b) transport up to the ABC Centre (Only a stipulated number of dogs corresponding to the housing capacity of the Animal Birth Control Centre shall be captured at any given time) (c) pre & post-operative feeding and care of stray dogs (dogs have to be kept for at least 4 days for post-operative care at the Centre and provided with nutritious food twice daily and shall have continuous access to potable drinking water at all times) (d) mass scale ABC Surgery & Anti Rabies Vaccination (e) Survey of dog population in various wards as per *Revised Module for Street Dog Population Management, Rabies Eradication and Reducing Man Dog Conflict* published by AWBI, (f) re-transport the dogs from ABC campuses back to their original street/location (g) community participation through pre-capture public messaging, awareness programmes and resolution of dog-related complaints, bite incidents and animal welfare concerns received on the Animal helpline number. The information of any dog bite shall be promptly shared with the Government Medical Hospital to recommend post bite treatment.





- 3.4 Municipal Corporation Saharanpur will provide electricity and water facilities in the ABC Centres. However, electricity and water charges shall be borne by the bidder
- 3.5 The bidder will carry out nearly 6000 ABC-ARV surgery including post-operative care in the Saharanpur Municipal Corporation.
- 3.6 The bidder shall attempt to achieve zero mortality, however the mortality rate must not exceed 0.5%, otherwise the contract shall be terminated. Mortality rate shall be checked after every 500 ABC-ARV surgeries through an organ inspection team comprising: (i) Chief Veterinary Officer or authorized Veterinary Officer; (ii) Project In-Charge Veterinary Officer; (iii) Representative of the State Board or Society for Prevention of Cruelty to Animals; (iv) Representative of an Animal Welfare Organisation (excluding the organization conducting the ABC program).
- 3.7 The bidder shall provide surgical equipment kit, Medicines, Suture Material, Computer, Stationery & Feeding material for the ABC centre and material for community awareness at its own cost, **for which no extra payment shall be made to the bidder.**
- 3.8 Payment for the ABC-ARV shall be made based on Organ Count Basis, verified by the organ counting team. Organ Count may be re-verified by AWBI/ SAW or State Government or any senior authority from Saharanpur Municipal Corporation. **Such payments are to be made on monthly basis.**
- 3.9 Payment shall be made after successful completion of ABC-ARV surgery including post-Operative care and re-transport the dogs from ABC campuses back to their original street/location. All statutory deductions, as applicable, shall be made from the eligible payment to the NGO.
- 3.10 The project shall include a buffer zone of 10 kilometres radius around the local authority's jurisdiction to ensure comprehensive program coverage.
- 3.11 There may be regular visits of Veterinary Doctors of Uttar Government & intern vets, to participate & gain exposure to ABC-ARV Program, for which bidder shall be expected to extend all the cooperation as directed by Urban Local Body
- 3.12 The Local Authority shall have the power to authorize inspection teams. Inspection teams can enter the ABC centre without prior notice and (a) Access all areas, examine animals and records, take photographs and video recordings, (b) Annual inspection of ABC Centres by Inspection Team is mandatory (c) Inspection reports to be submitted to Board and State Monitoring Committee
- 3.13 The bidder may be offered more ABC campuses within the same jurisdiction at the same terms and conditions and same cost to the government, in due course of time.
- 3.14 The local authority reserves the right to terminate or suspend the program's implementation based on recommendations from the State or Local ABC Monitoring Committee and non-adherence to ABC Rules 2023.


