1. Background:

Nagar Nigam, Saharanpur (NNS) entrusted with the crucial responsibility of managing the Municipal Solid Waste (MSW) generated across its urban and semiurban areas. At present, the city produces an average of approximately 391 metric tons per day (TPD) of MSW, which is a mix of biodegradable organic (wet) waste and non-biodegradable (dry) waste, including plastics, metals, textiles, and inert materials.

To support sustainable waste management in line with the Municipal Solid Waste Management Rules, 2016, and supporting renewable energy production, NNS intends to supply 150 TPD Minimum&180 TPD Maximum of segregated organic waste to Bharat Petroleum Corporation Limited (BPCL) on a daily basis for its proposed Compressed Bio Gas (CBG) plant at Ghunna Maheshwari.

To ensure proper segregation and preparation of high-quality organic feedstock, the NNS intends to install a mechanized pre-processing line and seeks expressions of interest (EOI) from eligible and experienced agencies to design, supply, install, commission, and maintain the necessary waste pre-processing machinery. The proposed solution must include equipment such as trommel screens, air density separators, ferrous separators, shredders, and associated conveyance systems. This system will play a pivotal role in separating and refining the organic fraction from the mixed municipal waste stream, ensuring that only clean, high-quality biodegradable waste is sent to the CBG facility.

2. Objective:

The primary objective of this Expression of Interest (EOI) is to identify and engage qualified agencies capable of providing a comprehensive solution for themechanized pre-processing of Municipal Solid Waste (MSW). Specifically, Nagar Nigam, Saharanpur seeks to obtain detailed technical proposals, including:-

- Complete cost estimates for supply, installation, and operation of the required machinery.
- Area requirements for setting up the Segregation line.
- A technical layout plan detailing equipment configuration and flow of waste.

The proposed system should be capable of:

- Handling of around 400 TPD or more of mixed municipal solid waste on a daily basis.
- Efficiently segregating organic waste to yield 150-180 TPD of pure organic waste suitable for CBG production.

3. Scope of Work:

The selected agency shall provide a turnkey solution and required to:

- a) Study the characteristics of Saharanpur's mixed MSW.
- b) Propose suitable technologies and equipment for pre-segregation (manual, semi-automated, automated).
- c) Estimate the land/area requirement for the segregation system.
- d) Provide detailed costing for:
 - Civil and electrical infrastructure.
 - Machinery and equipment.
 - Operational and maintenance costs.
- e) Supply, installation, testing, and commissioning.
- f) Training of operators.
- g) Operation and Maintenance (O&M) support for minimum 3-5 years.
- h) Spare parts availability and service warranty
- i) Recommend layout and workflow for optimal efficiency.

- j) Ensure that the segregated organic waste meets the quality norms required by BPCL for its CBG plant.
- k) Submit a comprehensive feasibility report.

4. Eligibility Criteria:

Interested agencies should:

- a) Have prior experience in waste processing or municipal infrastructure projects.
- b) Have successfully completed at least one similar project (segregation/processing of MSW) in the last 5 years.
- c) Be registered and compliant with relevant statutory and environmental laws.

5. Submission Requirements:

Firms interested to be considered for short listing may intimate office of Chief Engineer, Nagar Nigam, Saharanpur in writing about their technical capabilities. Following documents shall be enclosed with EOI, which will be used for short listing.

- a) List of similar assignments completed successfully with brief project description, relevancy, and information of cost of the services, cost of project, employer and funding agency. The agency should have prior experience in pre-processing fresh municipal solid waste (MSW) for a city with a population of over 5 lakh, or should have handled at least 250 TPD of MSW through pre-processing activities.
- b) List of similar works/ assignments in progress with brief project description relevancy, information of cost of the services, cost of project, employer and funding agency.
- c) Strategies and feasible methods for current project. The firms may be required to make a presentation.
- d) Company profile and a list of relevant skills with the staff and indicative Curriculum Vitae.
- e) Project delivery capability in India.
- f) Company registration certificate/s and document/s.
- g) Latest Annual Report and audited accounts.
- h) Document/s clearly showing last three (3) year annual turnover figures.
- i) Eligibility statement.

All above documents / certificates for the firm / and joint venture / consortium partners must be submitted in the EOI.

Only the firms having the required qualifications shall be considered for short detailed proposals.

Firms barred from participating in any project funded by the Govt of India/Govt of UP on the date of submission of their EOIs, will not be eligible to participate in this project. A declaration to that effect shall be furnished by applicants.

The complete proposal indicating the firm's interest in taking up the assignment with all relevant information as above copies of relevant documents for verification and full contact address shall be submitted in one hard copy and one soft copy at the address mentioned below on or before last date and time of submission of EOI given in the Notice Inviting Expression of Interest for this work.

No application shall be received after the deadline.

6. Presentation/Visit/Communication:

Presentation will be held on date specified in notice of EOI. Prospective applicantsmay visit the office of the Authority to review the available documents and data at anytime prior to last date of receipt of EOI. For the convenience of outstation applicants or those unable to attend in person, the SNN will also facilitate participation in the presentation through video conferencing.
